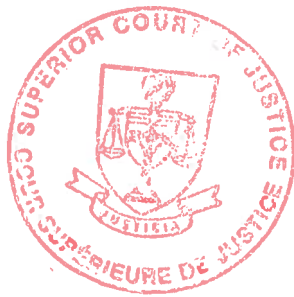

ORDER

WHEREAS certain health information custodians (the "Health Information Custodians") as defined in the *Personal Health Information Protection Act, 2004*, S.O. 2004, c. 3 Schedule A ("PHIPA") have custody and control of documents that contain personal health information of current and former students of W. Ross MacDonald School, including, but not limited to, medical records (the "Medical Documents");

AND WHEREAS the information contained in the Medical Documents constitutes "personal health information" (the "Personal Health Information") for the purposes of the PHIPA;

AND WHEREAS the Personal Health Information contained in the Medical Documents may be relevant to the determination of the issues raised in the within class proceeding;

AND WHEREAS subparagraph 41(1)(d)(i) of PHIPA permits a Health Care Custodian to disclose Personal Health Information about an individual for the purpose of complying with a summons, order or similar requirement issued in a proceeding by a person having jurisdiction to compel the production of information;

AND WHEREAS the parties have consented to this Order;

1. **THIS COURT ORDERS** that any Health Care Custodian served with a copy of this Order shall disclose any and all Medical Documents in his or her power, possession or control to the defendant, Her Majesty the Queen in right of Ontario (the "Crown").
2. **THIS COURT FURTHER ORDERS** that the Crown is hereby authorized to disclose and produce copies of Medical Documents and any other documents containing personal information to class counsel.
