

DISTRIBUTION OF SETTLEMENT AMOUNT TO SETTLEMENT CLASS MEMBERS

1. The following definitions apply in this Schedule:
 - (a) "Eligible Claim" means a Claim specified in Appendix 1 or a Previously Unknown Claim. The amount of a Class Member's Eligible Claim in Appendix 1 shall be adjusted to account for any amount the Class Member received from Service Canada through the Wage Earner Protection Program.
 - (b) "Individual Contribution For Legal Expenses" means the Settlement Class Member's *pro rata* share of all amounts in respect of legal fees, disbursements and applicable taxes to be paid to Koskie Minsky LLP (being the amount determined under paragraph 4(a)).
 - (c) "Individual Gross Allocation" means the *pro rata* share of each Settlement Class Member's entitlement to the Settlement Amount for Eligible Claims after deducting the amount paid to the Trustee pursuant to section 31(a) of the Settlement Agreement.
 - (d) "Individual Net Payment" means the amount to be paid for an Eligible Claim to an individual Settlement Class Member. The Individual Net Payment is equal to the Individual Gross Allocation minus
 - (i) the Individual Contribution For Legal Expenses; and
 - (ii) the amounts remitted to the Canada Revenue Agency by TSGI in respect of that Settlement Class Member's Eligible Claim pursuant to section 31 of the Settlement Agreement.
 - (e) "Net Settlement Amount" means the funds paid to Koskie Minsky LLP, in trust, pursuant to section 31 of the Settlement Agreement.
 - (f) "Pension Claim" means a Claim of a Settlement Class Member in respect of a reduction of benefits under the Pension Plan, calculated on a commuted value basis and based on the solvency deficit in the Pension Plan as of the wind up of the plan.
 - (g) "Pension Plan" means the Employees Retirement Plan of Stone & Webster Canada L.P., registration number 0515908.
 - (h) "Plaintiffs" means Ian Sansom, Robert Lukas, John McNab and Ed Dorr.
 - (i) "Previously Unknown Claim" means a Termination Claim, Pension Claim or such other Claim of a Settlement Class Member that is not listed in Appendix 1 and which is determined to be eligible for payment.

- (j) "Settlement Amount" means \$9,400,000.00.
- (k) "Settlement Agreement" means the settlement agreement between The Shaw Group Inc., Shaw Canada L.P., Stone & Webster Canada Holding One (N.S.), ULC., Stone & Webster Canada Holding Two, Inc. and the Plaintiffs entered into on September 10, 2013.
- (l) "Termination Claim" means a Claim by a Settlement Class Member in respect of termination of employment from Shaw Canada L.P.
- (m) "Total Claims" means the sum total of all Eligible Claims, as specified in Appendix 1 and all Previously Unknown Claims.

2. All other capitalized terms used in this schedule have the same meaning as in the Settlement Agreement and the Certification and Settlement Approval Order.

Goal

3. The goal of this distribution protocol is to divide the Net Settlement Amount among Settlement Class Members with Eligible Claims, net of contributions for legal costs and amounts to be remitted to the Canada Revenue Agency. The contribution for legal costs reflects a *pro rata* share of each Settlement Class Members' legal costs.

Distribution of Net Settlement Amount

4. The Net Settlement Amount shall be paid in the following order of priority:
- (a) Payment to Koskie Minsky LLP, in respect of all legal fees, disbursements and applicable taxes that have been and will be incurred and unpaid in advance of final distribution of the Net Settlement Amount, subject to any maximum amount that is specified in the Certification and Settlement Approval Order.
 - (b) Payment to each Settlement Class Member with an Eligible Claim in an amount equal to the Individual Net Payment.

Previously Unknown Claims

5. Koskie Minsky LLP, in consultation with the Plaintiffs, shall determine the eligibility of a Claim to be a Previously Unknown Claim and shall, if it is eligible, determine the quantum of such a Claim pursuant to paragraph 8.

6. For any Settlement Class Member that contacts Koskie Minsky LLP within 30 days of the Certification and Settlement Approval Order and who asserts that he or she has a Previously Unknown Claim, Koskie Minsky LLP shall investigate the claim and make reasonable efforts to assist that Settlement Class Member to provide full particulars of his or her purported Claim.
7. A Claim of a Settlement Class Member will be eligible to be considered under paragraph 5 as a Previously Unknown Claim if:
 - (a) the Settlement Class Member provides full particulars of his or her purported Claim to Koskie Minsky LLP by no later than 30 days following the Certification and Settlement Approval Order;
 - (b) the Settlement Class Member has not signed a release of the Claim and is not otherwise barred by law, contract or court order from advancing the Claim;
 - (c) in the case of a Termination Claim, the Settlement Class Member was an employee of Shaw Canada L.P. who was terminated on or after September 10, 2011;
 - (d) in the case of a Pension Claim, the Settlement Class Member, whether an active member, a deferred member, a retiree or the spouse of an active member, a deferred member or a retiree, will incur a reduction in his or her pension benefits as of the wind up date; and
 - (e) in the case of a Claim that is not a Termination Claim or Pension Claim, Koskie Minsky LLP determines it is a meritorious claim against The Shaw Group Inc., Shaw Canada or their affiliates.
8. A Previous Unknown Termination and Pension Claim shall be quantified by Koskie Minsky LLP as follows:
 - (a) For a Termination Claim, the claim shall be the amount of the persons' weekly pre-tax salary at the time of termination multiplied by a factor determined by Koskie Minsky LLP that is consistent with the factors applied to similarly situated terminated Settlement Class Member Claims, multiplied by the total number of years in full time employment at Shaw Canada L.P.
 - (b) For a Pension Claim, the claim shall be the amount that reflects the reduction, on an actuarial basis, of the reduction of the Settlement Class Members' pension benefit under the Pension Plan as a result of the Plans' solvency deficiency, calculated as of the wind up date.

- (c) For any other Claim, the claim shall be quantified taking into account any appropriate discounts for liability and recovery in Koskie Minsky LLP's sole discretion.
9. Koskie Minsky LLP shall notify the Settlement Class Member of the value of his or her Previously Unknown Claim as determined under paragraph 8.
10. The determinations of Koskie Minsky LLP with regard to the value of any claim under paragraph 8 and with regard to a determination under paragraph 5 and 7 are final, subject only to a review by way of motion to a judge of the Ontario Superior Court of Justice (Commercial List), within 20 days of Koskie Minsky LLP sending a notice to the Settlement Class Member of its determination. Such motion shall be in such form and manner as the judge hearing the motion shall direct.

Payment to Settlement Class Members

11. Koskie Minsky LLP shall arrange for the payments to Settlement Class Members and shall make such payments as soon as practicable after it receives payment of the Net Settlement Amount (from TSGI).
12. Payments to Settlement Class Members shall be made by bank transfer, cheque or such other method of payment as Koskie Minsky LLP deems appropriate, in consultation with the Plaintiffs.
13. If a payment is made by cheque and the Settlement Class Member does not cash the cheque within 3 months (a 'Failed Payment'), Koskie Minsky LLP shall attempt to contact the Settlement Class Member using the contact information in its records in order to remedy the Failed Payment. Section 59.6 of the *Law Society Act*, R.S.O. 1990, c. L.8 applies in respect of Failed Payments, pursuant to which Koskie Minsky LLP may apply for permission to transfer any unclaimed amount to the Law Society of Upper Canada.
14. Any data error may be corrected by Koskie Minsky LLP and any other matter not referred to herein shall be determined by analogy by Koskie Minsky LLP in consultation with the Plaintiffs.
