**UPON READING** the Defendant's submissions and Application materials, the Plaintiffs' submissions, and the submissions and materials of the Third Parties, the International Grenfell Association, the Moravian Union in Newfoundland and Labrador, the Moravian Union (Incorporated) and Her Majesty the Queen in Right of Newfoundland and Labrador, and

**UPON HEARING** the oral submissions of counsel for the Defendant, counsel for the Plaintiffs, and counsel for the Third Parties.

1. **THIS COURT ORDERS THAT** one common issues trial shall be held to resolve all of the common issues together, including all Third Party claims.
2. **THIS COURT ORDERS THAT** the common issues trial to resolve all of the common issues together, including the Third Party claims, shall commence on Monday, September 28, 2015, for twelve (12) weeks.
3. **THIS COURT ORDERS THAT** counsel for all parties shall meet with Justice Stack on December 15, 2014, to establish a timetable leading to the commencement of the common issues trial on September 28, 2015.
