Reference is made to: (i) the Plan of Compromise and Arrangement pursuant to the *Companies' Creditors Arrangement Act* concerning affecting and involving the Canadian Debtors dated November 30, 2016 (the "Canadian Plan") sanctioned by the Ontario Superior Court of Justice pursuant to a Sanction Order dated January 24, 2017; (ii) the Notice of the Initial Distribution Date issued by the Monitor dated June 8, 2017 (the "Initial Distribution Notice"), (iii) the Notice of Second Distribution Date issued by the Monitor dated November 14, 2018 (the "Second Distribution Notice") and (iv) the Notice of Third Distribution Date issued by the Monitor dated August 27, 2020 (the "Third Distribution Notice"). Capitalized terms used herein and not otherwise defined have the meaning given to them in the Canadian Plan or Third Distribution Notice.

NOTICE IS HEREBY GIVEN that the amount of the Third Distribution shall be:

- (i) <u>U.S. 3.70 cents per U.S. dollar</u> for holders of Proven Affected Unsecured Claims entitled under the Canadian Plan to be paid in U.S. dollars; and
- (ii) <u>approximately CA 4.05 cents per CA dollar</u> for holders of Proven Affected Unsecured Claims entitled under the Canadian Plan to be paid in Canadian dollars.

The Third Distribution, when combined with the Initial and Second Distributions, results in a cumulative distribution under the Canadian Plan to date of:

- (i) <u>U.S. 49.50 cents per U.S. dollar</u> for holders of Proven Affected Unsecured Claims entitled under the Canadian Plan to be paid in U.S. dollars; and
- (ii) <u>approximately CA 54.25 cents per CA dollar</u> for holders of Proven Affected Unsecured Claims entitled under the Canadian Plan to be paid in Canadian dollars.
