**By Order of the Ontario Superior Court of Justice, this is a notice to all persons resident in Canada, who purchased one or more tickets before March 25, 2020 using the StubHub platform for an event that has been canceled, and who have not received a refund.**

In May 2020, a proposed class proceeding was commenced against StubHub Canada Ltd. and StubHub, Inc. ("the Defendants"), in relation to the Defendants' alleged failure to provide refunds for tickets purchased on the StubHub platform for events that were cancelled as a result of the COVID-19 pandemic.

This notice is to advise you that the proposed class proceeding has been discontinued. The Ontario Superior Court of Justice has approved the discontinuance of this class proceeding and the discontinuance will take effect on **XXXX**.

**PLEASE TAKE NOTICE THAT** the limitation period for bringing a claim will begin to run again as of **XXXX**, which is the date the Order granting leave to discontinue takes effect. You may lose the right to sue after your limitation period expires.
